## Course Objective

• Ordinary differential equations (ODEs) are used to describe the dynamics of a wide variety of phenomena in many scientific and engineering contexts. Motivated by such a wide variety of applications, this course will provide necessary training for analyzing and solving ODEs, primarily of first and second order.

## Grading

Grading will be based on the total number of points earned by a student. The points will be divided as follows:

- Homeworks: 10%
  - Homework assignments will be due at the start of class on the following Tuesday. Only certain problems will be graded, at the choice of the instructor and after all homeworks have been collected. Full credit on a homework problem will only be given if the student shows work. The lowest three homework scores will be dropped, to accommodate both anticipated and unanticipated absences. Please see Late Homework Policy below.
- Weekly Quiz: 40%
  - With the exception of the Midterm Exam week, a short, timed quiz will be given at the start of class each Thursday. Each quiz will contain material based on the previous homework set. The lowest three quiz scores will be dropped, to accommodate both anticipated and unanticipated absences. At the end of the alotted time, quizzes must be handed in, or a penalty will be assessed.
- Midterm Exam (Thurs, Oct 2, normal class time/location): 20%
- Final Exam (Tues, Dec 16, 3–5PM): 30%
